9. Answer the following as True or False. No explanation is required:

(10 marks)

- a) A contract which is in its nature determinable can be specifically enforceable.
- **b)** Under Section 41 of the Specific Relief Act, 1963, an injunction can be granted to restrain any person from applying to any legislative body.
- c) Rule 10 (1) of Order 1 deals with striking out, addition and substitution of parties.
- **d)** The period of limitation for the execution of a decree (other than a decree granting a mandatory injunction) is 15 years from the date of the decree.
- e) An appeal shall not lie from an order refusing to restore an appeal.
- f) Section 89 deals with Settlement of Dispute outside Court.
- g) Section 148 provides that where any period is fixed or granted by the Court for the doing of any Act, the Court has power to enlarge the period even if the original period fixed has expired.
- **h)** An application for restitution lies to the court which has passed the decree or made the order.
- i) Whether a person is or is not a party to the Suit should be decided not on the basis whether he is a party to the decree but whether he is a party to the suit in which the decree is passed.
- j) At the hearing of a Summons for Judgment in a Summary Suit, the Judge may, if he/she grants leave to the defendant to defend, transfer the suit to the list of Commercial Suit.
