- 1. Answer whether True or False. Give 1 bullet point reason for 20 Marks your answer.
 - i. A preliminary decree is one which determines the rights of the parties with regard to some or one of the matters in controversy in the suit, which may have the effect of final disposal of the suit.
 - ii. A contract made by a trustee in excess of his powers or in breach of trust can be specifically enforced.
 - iii. A review is said to take place when the High Court calls for the record of any case decided by a subordinate court and passes an appropriate order.
 - iv. An inter pleader suit is one where the real dispute is between the Defendants only.
 - v. Article 142 of the constitution enacts that the law declared by the supreme court shall be binding on all courts in India.
 - vi. An order under Section 47 of the Code may be reversed on account of an irregularity in a proceeding relating to such order. vii. A civil revision application under Section 115 of the Code is maintainable against an order of the commercial court finding that it has jurisdiction to hear the dispute.
