1. Mr. A approaches you with for recovery of his residential premises let out on leave and license basis to Mr. B an individual who has continued to use and occupy the premises after the expiry of term of the leave and license agreement. Please advise Mr. A on the following queries:-

- i. Procedure for recovering the licensed premises from Mr. B.
- ii. Will your advice be different in case the leave and license agreement was not registered?
- iii. In case of commercial premises given on leave and license basis by Mr. A to Mr. B would you advice be different for recovery of the commercial premises.
- 2. Mr. A being the original tenant of Mr. B died on 1 September 2023 leaving behind his widow (Mrs. X), 3 sons, one daughter as his only legal heirs. Mr. A at the time of his demise was residing with Mrs. X at the time of his demise and his 4 children were residing in USA during the lifetime of Mr. A. After the demise of Mr. A, there is a family dispute between Mrs. X and her children in respect of tenancy rights. Please advise Mrs. X on the following queries:

- i. Who would become the tenant of Mr. B?
- ii. Would your advice differ if Mr .A bequeathed his tenancy rights to his daughter under his last Will and Testament?
- iii. In the event of Mrs. X pre-deceasing Mr. A who would become the tenant?
- 3. Mr. A has issued a demand notice to Mr. B, a tenant, demanding arrears of rent for 5 months. Pursuant to receiving the demand notice Mr. B pays the entire amount as demanded in 60 days. Please advise Mr A on the following queries:

- i. Whether the landlord can file a suit for eviction on the ground of arrears of rent?
- ii. Would your answer differ if Mr. B has made payment within 90 days from receipt of the demand notice sent by Mr. A?

iii. Can Mr. B be evicted by the court despite making payment of the entire arrears of rent as demanded by Mr. A?

4. Mr. A, the son of a Mr. X being the deceased member of PQR Cooperative housing society approaches you for transferring the share, right, title and interest of a Flat owned by Mr. X. Mr. X died intestate leaving behind a wife, one daughter and one Son (Mr. A) as his only legal heirs and representatives. Mr. X had made a 100% nomination in favour of his wife. Please advise Mr. A on the following queries:

- i. What are the legal documents required to be submitted by the legal heirs of Mr. X for transferring the share, right, title and interest of Mr X under Chapter XIII -B of the Maharashtra Cooperative Societies Act, 1960?
- ii. What will be the rights of the nominee?
- 5. Mr. A purchased a flat on 5 January 2023 by a registered sale deed in a Co-operative housing society from Mr. B. The society, after receiving the society transfer forms and transfer fees, endorsed the name of Mr. A on the society share certificate on 5 February 2023. Mr. C is negotiating for purchase of flat from Mr. A and wants to complete the transaction by 31 December 2023. Please advise Mr C on the following queries:
